

# Transfer Partner Agreement



This agreement is entered into as of \_\_\_\_\_ date \_\_\_\_\_, by and between \_\_\_\_\_ Organization \_\_\_\_\_ (hereafter referred to as "Transfer Partner" and VVAPL Humane Society, a California non-profit public benefit corporation (hereafter referred to as "VVAPLHS", for the purpose of placing animals with transfer partner.

1. Whereas, any unaltered animal will be altered within 30 days at Transfer Partners expense prior to animal being adopted. Proof of said surgery will be sent to VVAPLHS.
2. Whereas Transfer Partner is an animal rescue or adoption organization with 501 c3 and wishes to obtain animals for the purpose of finding suitable adoptive homes.
3. Transfer Partner shall provide animals obtained from VVAPLHS with a healthy, clean and safe environment and shall provide the animals with necessary and prompt veterinary care when needed, nutrition and shelter at Transfer Partners expense.
4. Transfer Partner shall keep accurate records of each animal obtained from VVAPLHS, such as adopters address, telephone number, microchip number of animal (VVAPLHS will register 24 pet).
5. Transfer Partner will provide VVAPLHS with a list of authorized persons to remove animals for the VVAPLHS and is responsible to keep list current.
6. Transfer Partner shall use the term "transfer/transferred" when referring to animals obtained from the VVAPLHS. The term "pull" shall not be used when posting on social media or speaking to potential adopters.
7. Transfer Partner agrees to not use descriptions such as: emaciated, abused, death row, in conjunction with VVAPLHS.
8. Any animal may be returned at anytime for any reason to the VVAPLHS.
9. Transfer Partner assumes all financial responsibility for animals in care and understands VVAPLHS will not reimburse for said expenses.
10. Transfer Partner is in compliance with all local regulations, such as kennel license, number of animals allowed, health and civil codes.
11. Transfer Partner shall arrange for all necessary transportation and fees.
12. Transfer Partner and VVAPLHS each release the other party and such other party's officers, agents and employees from all claims, demands, judgments, awards, fines, liens, losses, damages and expenses. Including attorneys' fee and court costs. The provisions of this paragraph shall survive the termination of cancellation of this agreement. Any dispute or claim arising out of or in relation to this contract, or any breach or alleged breach shall be settled by binding arbitration.
